

## 1. DRAFT CONSTITUTION - WASTE STRATEGY WORKING GROUP



## Hornsby Council Waste Strategy Working Group

## CONSTITUTION

(March 2018)

1 <u>NAME</u>

The name of the Committee shall be "Waste Strategy Working Group".

## 2 THE COMMITTEE

The Committee shall consist of a maximum of 10 members namely:

- Four (4) nominated Councillors; All other Councillors can be ex officio members of the Committee but will not be entitled to vote other than in the absence of the Councillors who are members of the Committee.
- Two (2) technical specialists from the Environment and Human Services Division being Group Manager, Environment and Human Services Division and Manager, Waste Management or other related professionals with expertise in waste management;
- Four (4) community representatives.

## 3 <u>QUORUM</u>

The quorum of the Committee for all Ordinary and Extraordinary meetings shall be four (4) members.

## 4 <u>CHAIRPERSON</u>

4.1 The Chairperson shall be selected from the nominated Councillors and be appointed at the first Committee meeting of each Council year.

- 4.2 The Chairperson shall preside at each meeting of the Committee and shall be responsible for liaison with Council.
- 4.3 In the absence of the Chairperson, the Committee shall appoint an acting Chairperson for that meeting only, within fifteen (15) minutes of the stated starting time of such meeting.

### 5 COMMITTEE SUPPORT

- 5.1 The committee will receive administrative support for the taking of Committee Minutes. Support staff may participate in discussion but shall not be entitled to vote.
- 5.2 A suitably experienced and qualified specialist consultancy in solid waste management will be engaged to work in collaboration with the Committee to develop Council's Waste Management Strategy.

### 6. VACANCY

In the event of a vacancy occurring on the Committee through resignation or default, a new Committee member can be accepted by the Committee. In this case, default means absence from three (3) consecutive meetings of the Committee without leave of absence.

### 7. PURPOSE OF THE COMMITTEE

The purpose of the Committee shall be to assist Council to develop a Waste Management and Resource Recovery Strategy that will establish the strategic directions for waste management and resource recovery within the Shire over the next five (5) years.

## 8. OBJECTIVES

The objectives of the Committee shall be:

- To assist Council in developing Council's Waste Management and Resource Recovery Strategy (the Strategy) including:
  - Examination of best practice strategies to achieve the NSW State Government Waste and Resource Recovery (WARR) Act and Strategy target for domestic waste
  - Ensuring that waste management and resource recovery strategies proposed are socially, environmentally and economically responsible and do not expose Council or the Community to unacceptable levels of risk
- To consider community needs and requirements related to Council's provision of waste services and to facilitate community consultation within the Strategy development process;

- To examine options for the pending suite of new waste contracts including: Collection Services; Acceptance, Processing and Marketing of Recyclables; Acceptance, Processing and Marketing of Green Waste; and Advanced Waste Treatment and Disposal Services;
- To examine how Council will respond to emerging challenges and opportunities within the waste and resource recovery sector.

## 9. <u>AUTHORITY</u>

The Committee will have the authority to discuss matters and make recommendations for consideration by Council, but not to make decisions on Council's behalf.

## 10. MEETINGS

- 10.1 The Waste Working Group Committee is not a committee within the meaning of the Local Government Act 1993.
- 10.2 The conduct, frequency and format of meetings are at the discretion of Council.
- 10.3 Meeting formats may include ordinary meetings, workshops, facility tours and extraordinary meetings as required.
- 10.4 The Committee may attend waste industry facility tours (recycling and waste processing plants in and around and servicing the Sydney Metropolitan Area), waste industry consultation and briefing sessions, and hold strategic planning workshops with committee members.
- 10.5 The organisation of meeting is the responsibility of the Waste Management Branch representative (Manager, Waste Management).
- 10.6 Each Committee member is entitled to vote on resolutions.

## 12 MINUTES/AGENDA

- 12.1 Preparation of agendas and/or minutes shall be prepared for Ordinary and Extraordinary (face-to-face) meetings.
- 12.2 Preparation and distribution of the agenda and minutes for each meeting shall be the responsibility of the representative of the Waste Management Branch.
- 12.3 Copies of minutes from meetings shall be retained on Council file.
- 12.4 The public may access have to the minutes from meetings in accordance with the Government Information (Public Access) (GIPA) Act 2009.

### 14 DISSOLUTION

- 14.1 The Committee will be dissolved when Council formally adopts the Waste and Resource Recovery Strategy.
- 14.2 Dissolution of the Committee shall be at the discretion of the Council of the Shire of Hornsby.
